

Checklist for the submission of subsequent verifications and the application

for the Environmental label according to DE-UZ 14a for "Graphic paper and cardboard made from 100% recovered paper".

Subsequent verifications are documents that must be submitted annually after the conclusion of a contract on the use of the Ecolabel.

Please upload the **subsequent verifications** only via the web portal in document form with reference to the contract number.

Annex 2: Printed form, all information relevant to the paper such as product name, weight, bisphenol A/S measurement. Upload as an Excel file

Annex 2 regular recurring inspection Form, All paper-relevant data: Product name, Bisphenol A/S Measurement as repeat inspection. Annually: Upload as Excel file	
Annex 2 E For extension applications and contracts- paper list. Upload as Excel file	
Determination of the DIPN content: Test report according to Paragraph 3.2 Only if the following types of paper are used: 2.05.00, 2.05.01, 2.06.00, 2.06.01 and 5.09. Annually: Upload as a document.	
Determination of the Bisphenol A/S content: Test report according to Paragraph 3.3 Annually: Upload as a document.	
Determination of the VOC content, every 2 years: Only for manufacturers of office and digital printing paper. Test report from an approved testing institution according to Paragraph 3.13. Upload as a document.	
Durability of the paper: Test report from an independent testing institution according to Paragraph 3.16 Only for manufacturers of office paper and paper used for the production of printed matter and press products. Upload as a document.	
Annex 3:	Printed form, declaration from the chemical producer/supplier according to Paragraphs 3.4, 3.9, 3.10 and 3.11, Upload as a document.
Annex 4:	Printed form, direct discharger - declaration from the manufacturer about the measured emission values according to Paragraph 3.14.1, Upload as a document.
Annex 5:	Printed form, confirmation from the operator of the waste water treatment plant about compliance with the emission values according to Paragraph 3.14.2. Upload as a document.
Annex 6:	Printed form, annually , confirmation from an external auditor about compliance with the requirements in Paragraph 3.1, Upload as a document.
